

# A simple funeral guide for Muslims



Eternal Gardens الطريق الى جنة الخلد Arranging an Islamic funeral comes with many anxieties and pressures. To help you navigate this difficult period, we've summarised the main steps of arranging your loved one's funeral into a check list to make it more manageable and easier for you.

### Simple steps summary

The main steps you will need to think about are:

- 1. Getting the medical certificate from the doctor
- 2. Registering the death at the local council office
- 3. Booking the Funeral Director service who will guide you through:
  - a. Transporting your loved one to the place of washing
  - b. Washing (Ghusl)
  - c. Shrouding (Kafan)
  - d. Transport to the prayer venue and then to the cemetery
  - e. Arranging the funeral prayer
- 4. Booking the burial plot and burial service
- 5. Using the above details to advise friends and family of the funeral arrangements

### **Obtaining the medical certificate**

A doctor involved in your loved one's care will complete a medical certificate of cause of death (MCCD) before the death can be registered and the next steps can take place.

Some circumstances will involve a coroner before the MCCD can be granted. This would include unexpected death at home, in which either the GP or the Police should be called, who will refer the matter to the coroner.

Our team are at hand to support you and signpost you to the right support if the case has been referred to the coroner.

## **Register the death**

You'll need to register the death with the Registrar of deaths within the locality of where the death occurred before your loved one can be discharged from the hospital. Many are able to offer urgent appointments for religious reasons, so ensure you check for those options.

- Transport

### **Arrange the burial**

Once you have discussed the burial options with the Funeral Director, you will need to book a burial plot and burial service slot. The Funeral Director may be able to offer some options as part of their services, however it is always best for the family to be aware and consider all options available to them locally.

### Some important considerations would be:

- Shariah compliancy and your loved one's religious wishes
- Graves facing Qiblah
- Affordability and value against other options
- Options and features (maintenance standards, options for securing plots for other family members, access and ease)

**IMPORTANT NOTE:** The 'Certificate for Burial' will have to be provided to the cemetery before a burial can legally take place. Ensure this is emailed to info@eternalgardens.org.uk or taken by yourself or the Funeral Director when arranging the burial.
